The National Charter Schools Institute's **#LEAD: Charter School Leaders Program** is an initiative to inspire, educate and equip charter school leaders to achieve their full potential and lead with excellence. #LEAD provides a broad overview of the knowledge and skills necessary to successfully lead a charter school in Michigan. Through participation in #LEAD, your school's leader, will be connected to other leaders, experts, resources, and organizations that will ensure your school's success.

#LEAD is designed to meet the unique needs of each participant and to build upon on the important work that is already being done in your school. All the activities that your school leader will be asked to complete are grounded in real-life work-based experiences. As part of this program, participants will be assigned a mentor who is an experienced school leader and will help guide your school's leader through their journey of leadership development.

The NCSI is currently accepting applications for #LEAD. Participants commit to completing 16 course modules, participating in 240 hours of field experiences and meeting with their mentor on a regular basis. The cost for participating in the ACSLP is \$9850. Title II funds can be used to help offset the cost of participating in the program.

We understand that one of the factors that attribute to a candidate's success, in this program, is the support of their governing board. Therefore, we are asking each applicant to verify that they have their board's full support by having their board president complete and return the enclosed form.
